Whereas the land specifications whereof are given below is required for public purposes viz. for Widening of Rajouri-Sair-Pouni road to double lane specification at village Sair, Tehsil Kalakote, District Rajouri by GREF;

Whereas on the basis of an indent placed by Officer Commanding, 56 RCC(GREF) vide 56 APO datd:01-08-2005 a notification under section 4(1) was issued by Collector Land Acquisition (Defence), Rajouri/Poonch, HQ Rajouri vide No.Coll/Def/408-13 dated:28-09-2015 for land measuring 03 Kanals and 08 Marlas, situated in village "Sair", Tehsil Kalakote , District Rajouri;

Whereas District Collector (DC) Rajouri vide his letter No. Coll/Def/438 dated:23-08-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by the Deputy Commissioner, Rajouri vide No. referred to above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purposes viz. for Widening of Rajouri-Sair-Pouni road to double lane specification at village Sair, Tehsil Kalakote, District Rajouri by GREF;

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Svt, 1990, it is declared that land measuring **03 Kanals and 08 Marlas**, situated in village "Sair", Tehsil Kalakote, District Rajouri particulars whereof are given above, is required for **public purpose viz. for Widening of Rajouri-Sair-Pouni road to double lane specification at village Sair, Tehsil Kalakote, District Rajouri by GREF**. Further, the Collector Land Acquisition,(Defence),Rajouri /Poonch, HQ Rajouri, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.




