Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division, Budhal vide No. EE/PMGSY/B/511-13 datd:16-07-2014, a notification under section 4(1) was issued by Collector Land Acquisition (ACR), Rajouri vide No. AC/LA/441-43 dated: 08-08-2014 for land measuring 12 Kanals and 15 Marlas, situated in village "Bai-Nambal", Tehsil Koteranka, District Rajouri;

Whereas the District Collector (DC) Rajouri, vide No. AC/LA/515-17 dated: 06-01-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector Land Acquisition (ACR) Rajouri, was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by District Collector (DC) Rajouri vide his letter referred to above, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof is given above is required for public purposes viz. for Construction of road from Khandi Gali to Kanthol in village Bai-Nambal, Tehsil Koteranka, District Rajouri, under PMGSY;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 12 Kanals and 15 Marlas situated in village "Bai-Nambal", Tehsil Koteranka, District Rajouri, particulars whereof is given above is required for public purpose viz. for Construction of road from Khandi Gali to Kanthol in village Bai-Nambal, Tehsil Koteranka, District Rajouri under PMGSY. Further, the Collector Land Acquisition,(SDM) Koteranka, is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
