Whereas on the basis of indent placed by Executive Engineer, PMGSY Division Ramban, videNo. PMGSY/R/1555-56 dated.04-03-2016, a notification under section 4 (1) was issued by Collector, Land Acquisition, (ACR) Ramban, vide No. Acq/PMGSY/16/172-83 dated 01-06-2016 for land measuring 09 Kanals & 09 Marlas situated at village Deswal, Tehsil Rajgarh, District Ramban;

Whereas the Collector Land Acquisition (ACR) Ramban vide No. ACq/PMGSY/16/472-75 dated 30-11-2016 has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 &5 –A of the Land Acquisition Act;

Whereas the report furnished by Collector Land Acquisition (ACR) Ramban, vide above referred letter duly endorsed by District Collector, (DC) Ramban, vide No. DC/LA/63-64 dated 23-12-2016, , has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land referred above, is required for public purpose viz., for construction of Power House to Rajgarh Road under PMGSY in Tehsil Ramban (Now Rajgarh), District Ramban; and

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **09 Kanals and 09 Marlas situated at village Deswal, Tehsil Rajgarh, District Ramban**, particulars whereof are given above, is required for public purposes viz. for construction of roads from Power House to Rajgarh under PMGSY. Further, the Collector Land Acquisition (ACR) Ramban, is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
