Whereas, the land specifications whereof are given below is required for public purposes viz. "Acquisition of land for Middle School Lamberi by Education Department";

Whereas, on the basis of an indent placed by Director School Education, Jammu vide DSEJ/P/331/2015-16/70658-61 datd:15-03-2016, a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Nowshera, vide No.SDM/NSR/LA/43-46 dated:23-05-2016 for land measuring **04 Kanals and 15 Marlas** situated in village "Lamberi", Tehsil Nowshera, District Rajouri; and

Whereas, the Collector Land Acquisition (SDM) Nowshera, vide No. SDM/NSR/LA/43-46 dated:23-05-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas, the report furnished by the Collector Land Acquisition (SDM) Nowshera vide mentioned above and endorsed by the Deputy Commissioner, Rajouri vide No.AC/LA/394-95 dated: 28-11-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas, the Government is satisfied that the land particulars whereof are mentioned above is required for public purposes viz. "Acquisition of land for Middle School Lamberi by Education Department".

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 04 Kanals and 15 Marlas situated in village "Lamberi", Tehsil Nowshera, District Rajouri, particulars whereof are given above, is required for public purposes viz. "Acquisition of land for Middle School Lamberi by Education Department", Further, the Collector Land Acquisition,(SDM) Nowshera, is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.


