Whereas the land specifications whereof are given in “Annexure “A” to this notification, is required for **public purpose viz. for construction of Major Morh 6005 road by GREF;**

Whereas on the basis of an indent placed by Officer Commanding, 79 RCC(GREF), a notification under section 4(1) was issued by Collector Land Acquisition (Defence), Rajouri/Poonch, HQ Rajouri vide No.Coll/Def/592-97 dated:08-01-2015 for land measuring **25 Kanals and 16 Marlas** situated in village “Uchhad”, Tehsil Mankote, District Poonch;

Whereas the Deputy Commissioner, Poonch vide letter No. Coll/Def/320 dated:11-07-2016, has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by the Collector Land Acquisition (Defence)], Rajouri/Poonch, HQ Rajouri was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Deputy Commissioner, Poonch, vide letter referred to above, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are mentioned are given at “Annexure-A” to this notification, is required for **public purpose viz. for construction of Major Morh 6005 road by GREF;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **25 Kanals and 16 Marlas** situated in village “Uchhad”, Tehsil Mankote, District Poonch, particulars whereof are given in “Annexure –A” to this notification is required for **public purpose viz. “for construction of Major Morh 6005 road by GREF.** Further, the Collector Land Acquisition,(Defence),Rajouri /Poonch, HQ Rajouri is directed under **Section 7** of the

said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
