Whereas on the basis of an indent placed by Director Colleges, Higher Education Department vide No. HE/plan/GDC-Kalakote/2017 dated:13-12-2017 a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Kalakote vide No. SDM/KK/548 dated: 27-09-2017 for land measuring **02 Kanal and 02 Marlas**, situated in village Sair, Tehsil Kalakote, District Rajouri;

Whereas the District Collector (DC) Rajouri, vide No. AC/LA/1182-83 dated: 22-01-2018 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition **and some objections were received in the office of concerned collector in response to above notification within the prescribed period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by District Collector (DC) Rajouri vide number referred to above has been examined and it has been found that the land owner had filed objections to the proposed acquisition but the same stand disposed off in accordance with the law;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for construction of Government Degree College, Kalakote in village Sair, Tehsil Kalakote District Rajouri by Higher Education Department;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land 02 Kanal and 02 Marlas, situated in village Sair Tehsil Kalakote, District Rajouri, particulars whereof are given above is required for public purpose viz. for construction of Government Degree College, Kalakote in village Sair, Tehsil Kalakote District Rajouri by Higher Education Department. Further, the Collector Land Acquisition (SDM) Kalakote is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation, amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
