Notification No. 153 -Rev(LAJ) of 2018
Dated : 16 -01-2018.

Whereas the land, specification whereof are given in "Annexure-A" to this notification, is required for public purpose, viz for construction/widening of link road from Hasti Sarthal Devi Ji Village Agral, Tehsil Kishtwar, District Kishtwar;

Whereas on the basis of indent prepared by Executive Engineer PWD (R&B) Division, Kishtwar, a notification under section 4 (1) was issued by Collector, Land Acquisition (ACR) Kishtwar vide No. ACR/LA/1866-70 dated 28-02-2017, for land measuring 43 Kanals and 17 Marlas, situated in village Agral, Tehsil and District Kishtwar;

Whereas, the Collector Land Acquisition, Kishtwar vide No. ACR/LA/2017/2851-54 dated 04-01-2018, has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5-A of the Land Acquisition Act;

Whereas, the report furnished by Collector Land Acquisition (ACR) Kishtwar, vide above referred letter duly endorsed by District Collector, (DC) Kishtwar, vide No. DCK/LA/2017/885-89 dated 07-02-2018, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz construction/widening of link road from Hasti Sarthal Devi Ji Village Agral, Tehsil Kishtwar, District Kishtwar.

Now therefore, in pursuance of Section 6 of the J&K State land Acquisition Act, Samvat 1990, it is declared that the land measuring 43 Kanals and 17 Marlas, situated in village Agral, Tehsil and District Kishtwar, particulars whereof are given above, is required for public purposes viz for construction/widening of link road from Hasti Sarthal Devi Ji Village Agral, Tehsil Kishtwar, District Kishtwar. Further,

the Collector Land Acquisition (ACR), Kishtwar is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (S) as required under the Land Acquisition Act/rules.

Further, in pursuance of section 17 of the Land Acquisition Act, Samvat 1990, it is also ordered that on expiry of fifteen days from the publication of the Notification under Section 9 (2) of the said Act, the Collector will take possession of the aforementioned land in Village Agral, Tehsil & District Kishtwar, required for public purposes, subject the fulfillment of the conditions prescribed under Section 9 2) and Section 17-A of the Land Acquisition Act and Rule 63 of the Land Acquisition Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
