Whereas on the basis of indent prepared by District Collector, Deputy Commissioner, Udhampur vide No. DCU/SQ/5902-07 dated 13-12-2017, a notification under section 4 (1) was issued by Collector, Land Acquisition (ACR) Udhampur, vide No. ACRU/SQ/5981-91 dated 15-12-2017, for land measuring 08 Kanals 01 Marlas & 04 Sarsai situated in Village Kangeroo, Tehsil & District Udhampur;

Whereas the Collector Land Acquisition (ACR) Udhampur vide No. ACRU/SQ/5876 dated 03-01-2018 has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5-A of the Land Acquisition Act;

Whereas, the report furnished by Collector Land Acquisition, ACR Udhampur, vide above referred letter duly endorsed by District Collector, (DC) Udhampur, vide No. DCU/SQ/5881-85 dated 03-01-2018, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., for construction of Radio Station in village Kangeroo (Malhar) Tehsil and District Udhampur;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring 08 Kanals & 1 Marlas & 04 Sarsai situated in Village Kangeroo (Malhar), Tehsil & District Udhampur, particulars whereof are given in "Annexure A" is required for public purposes viz. for construction of Radio Station in village Kangeroo (Malhar) Tehsil and District Udhampur. Further, the Collector Land Acquisition (ACR) Udhampur is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
