Whereas on the basis of indent prepared by Executive Engineer, PWD Sub-Division Gandoh vide No. 4423-27 dated. 23-02-3010 a notification under section 4 (1) was issued by Collector, Land Acquisition (SDM) Gandoh, vide No. 126-32/LAS dated 30-05-2016, for land measuring 03 Kanals 19 Marlas situated in Village Chilly Paine Part-IV, Tehsil Gandoh & District Doda;

Whereas the Collector Land Acquisition (SDM) Gandoh, vide No. 429-30/LAC dated 18-12-2017 has reported that the notification issued under section 4 (1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5-A of the Land Acquisition Act;

Whereas, the report furnished by Collector Land Acquisition , (SDM) Gandoh, vide above referred letter duly endorsed by District Collector, (DC) Doda, vide No. 666/LAC/D/17 dated 03-02-2018, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., for construction of Bhatyas Manoo road at village Chilly Paine Part-IV Tehsil Bhalessa, District Doda;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring 03 Kanals & 19 Marlas situated in Village Chilly Pain Part-IV, Tehsil Gandoh District Doda, particulars whereof are given above is required for public purposes viz. for construction of Bhatyas Manoo road at village Chilly Paine Part-IV Tehsil Bhalessa, District Doda. Further, the Collector Land Acquisition (DC) Doda is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
