Subject:- Application of Sh. Ghulam Mustafa Sheikh S/O Late Ghulam Ali Sheikh R/O Village Chinote, Tehsil Bhaderwah, District Doda regarding de-notification of land measuring 11 Marlas falling under Kh. No. 132 situated at village Chinote acquired for construction of College Link Road.

Whereas, on the indent placed by the Executive Engineer, PW(R&B) Division Bhaderwah, land measuring 11 Marlas falling under kh. No. 132, situated in village Chinote was earlier acquired for construction of College Link Road;

Whereas, Financial Commissioner, Revenue vide No. FC-LS/LA-4618/2018 dated: 06-03-2018 is reported that the Collector Land Acquisition (ADC) Bhaderwah has intimated that two residential houses, two shops and some fruit bearing trees existing on the land measuring 11 Marlas comprising khasra No. 132 is under the possession of Gh. Mustafa Sheikh and land has been mutated in favor of PWD ;

Whereas, above named person has represented before the Collector, Land Acquisition (SDM) Bhaderwah stating that the land in question measuring 11 Marlas comprising khasra No. 132 has been acquired but the indenting department has not taken the possession of the said chunk of land and has constructed the road in other khasra numbers;

Whereas, ADC, Bhaderwah has added that the residential house has been constructed on the said khasra number prior to final award i.e 1988-89. However, the shops have been constructed after issuance of the final award and the indenting department (XEN PWD) Division Bhaderwah has intimated that the acquired land is no more required by the PWD for the purpose of construction of College Link Road;

Whereas, the Financial Commissioner, Revenue has requested for de-notification of the said land which was acquired earlier;

Whereas, the case has been examined and it has been found that the land measuring 11 Marlas comprising khasra No. 132 for which Final Award stands issued needs to be de-notified;

Now, therefore, in exercise of the powers conferred by Section 46 of the Land Acquisition Act 1996 read with Rule 43 of the Land Acquisition Rules, land measuring 11 Marlas falling under kh. No. 132 situated in village Chinote, Tehsil Bhaderwah is hereby de-notified, from requisite acquisition proceedings, ab-initio.
