Whereas the land specifications whereof are given below is required for **public purpose viz. for 4-laning of National Highway in village Lalipora Malpora, Tehsil & District Anantnag by NHAI;**

Whereas on the basis of an indent placed by Project Director, PIU, vide No. PD/SGR/14009/01/2014/LA-Ang/212 dated: 03-01-2018, a notification under section 4(1) was issued by Collector Land Acquisition (ADC) Anantnag vide No.547-50/LA/Ang dated: 21-10-2017 for land measuring **09 Marlas and ½ Sarsai** situated in village **Lalipora Malpora**, Tehsil & District Anantnag;

Whereas the Deputy Commissioner, Anantnag vide letter No. 779/LA/Ang dated: 22-01-2018, has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act.**

Whereas the report furnished by Deputy Commissioner, Anantnag vide letter referred above duly endorsed by Divisional Commissioner, Kashmir vide No.DivCom/LAS-Acq/2483/3890 dated: 05-02-2018 and by Financial Commissioner, Revenue vide No. FC-LS/LA-2606/07-18 dated: 06-03-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required **for public purpose viz. for 4-laning of National Highway in village Lalipora Malpora, Tehsil & District Anantnag by NHAI;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Svt, 1990, it is declared that land measuring **09 Marlas and 1/2 Sarsai** situated in village **Lalipora Malpora**, Tehsil & District Anantnag, particulars whereof are given above is required for **public purpose viz. for 4-laning of National Highway in village Lalipora Malpora, Tehsil & District Anantnag by NHAI**. Further, the Collector Land Acquisition (ADC) Anantnag is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

Now, in pursuance of section 17 of the Land Acquisition Act, Samvat 1990, it is ordered that on expiry of fifteen days from the publication of the notification under section 9(2) of the said Act, the Collector will take possession of the aforementioned land in village Lalipora Malpora, Tehsil & District Anantnag required for public purpose, subject to fulfillment of the conditions prescribed under section 9(2) and section 17-A of the Land Acquisition Act and Ruls 63 of the Land Acquisition Rules;

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
