Whereas the land specifications whereof are given in "Annexure
"A" to this notification is required for **public purpose viz. for construction
of Parking in village Rampur, Tehsil & District Rajouri by Urban
Development Department;**

Whereas on the basis of an indent placed by Executive Officer
Municipal Committee, Rajouri vide No. MC/R/2017-18/1190-93 dated: 29-
12-2017, a notification under section 4(1) was issued by Collector Land
Acquisition (ACR) Rajouri vide No. DCR/1712-14 dated: 01-01-2018 for
land measuring 10 Kanals, 03 Marlas and 08 Sarsai, situated in village
Rampur, Tehsil & District Rajouri;

Whereas the District Collector (DC) Rajouri vide No. AC/LA/1170-
71 dated: 19-01-2018 has reported that the notification issued under section
4(1) of the J&K State Land Acquisition Act was served upon the interested
persons for filing objections, if any, to the proposed acquisition, **but, no
objection was received from the land owners /interested persons in the
prescribed time period as required under section 5 & 5-A of the Land
Acquisition Act;**

Whereas the report furnished by District Collector (DC) Rajouri vide
No. referred above duly endorsed by Divisional Commissioner, Jammu vide
No.502/3088/Acq/Parking/Rampur/Raj/18/4320-23 dated: 15-02-2018 and
by Financial Commissioner, Revenue vide No. FC-LS/LA-4615/2018 dated:
06-03-2018 has been examined and it has been found that the land owners
did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof
are given in "Annexure-A" to this notification, is required **for public
purpose viz. for construction of Parking in village Rampur, Tehsil &
District Rajouri by Urban Development Department;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land
Acquisition Act, Samvat, 1990, it is declared that land measuring 10 Kanals,
03 Marlas and 08 Sarsai, situated in village Rampur, Tehsil & District

Rajouri, particulars whereof are given in "Annexure -A" to this notification, is required for public purposes viz for construction of Parking in village Rampur, Tehsil & District Rajouri by Urban Development Department. Further, the Collector Land Acquisition (ACR) Rajouri, is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.


