Subject:- De-notification of land measuring 05 Marlas falling under Kh. No. 535/262 situated at village Sarna, Tehsil Bhaderwah, District Doda acquired for construction of Tourist Reception Centre.

Whereas, on the indent placed by the Chief Executive Officer, Bhaderwah Development Authority(BDA) land measuring 05 Marlas falling under kh. No. 535/262, situated in village Sarna, Tehsil Bhaderwah, District Doda was earlier acquired for construction of Tourist Reception Centre;

Whereas, Financial Commissioner, Revenue vide No. FC-LS/LA-4617/2018 dated: 06-03-2018 has reported that the Collector Land Acquisition (ADC) Bhaderwah has intimated that subject land including residential house existing thereon acquired by the BDA is out of the boundary wall of the Bhaderwah Development Authority, for which a report was called from the Tehsildar Bhaderwah, who has reported that the indenting department has not taken the possession of the said piece of land;

Whereas, Sh. Ghulam Nabi S/O Sh. Gais-ud-Din Mir R/O village Sarna attorney holder represented before the Collector Land acquisition (SDM) Bhaderwah and requested that the land bearing Kh. No. 532/262 measuring 05 Marlas on which his residential house also exists was acquired by the Bhaderwah Development Authority for construction of the Tourist Reception Centre (TRC), as the Bhaderwah Development Authority has conveyed that the land is not required by them and has no objection if the same is de-notified.

Whereas, the Financial Commissioner, Revenue has requested for de-notification of the said land which was acquired earlier for construction of Tourist Reception Centre;

Whereas, the case has been examined and it has been found that the land measuring 05 Marlas falling under kh. No. 535/262, situated in village Sarna, Tehsil Bhaderwah, District Doda which was earlier acquired for construction of Tourist Reception Centre needs to be de-notify;

Now, therefore, in exercise of the powers conferred by Section 46 of the Land Acquisition Act 1996 read with Rule 43 of the Land Acquisition Rules, land measuring 05 Marlas falling under kh. No. 535/262, situated in village Sarna, Tehsil Bhaderwah, District Doda is hereby de-notified, from all acquisition proceedings, ab-initio.
