Whereas the land, specification whereof are given below is required for public purpose, viz. for construction of road from Main road Berigam to Gundipota situated at village Berigam, Tehsil Devsar, District Kulgam;

Whereas , on the basis of indent placed by Executive Engineer, PWD(R&B) Division Qazigund, a notification under section 4 (1) was issued by Collector, Land Acquisition (ACR), Kulgam vide No. DCK /LA-552/2017/578-85 dated 28-08-2017 for land measuring 01 Kanals and 05 Marlas & 07 Sirsai situated at village Berigam, Tehsil Devsar, District Kulgam;

Whereas, the District Collector (DC) Kulgam vide No. DCK/LA-552/2017/764-68 dated 12-12-2017 has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, and Mohd. Ismail Dar and others had filed objection within the prescribed period and after examination which were disposed of in accordance with the rules

Whereas, the report furnished by District Collector (DC) Kulgam, vide above referred letter duly endorsed by Divisional Commissioner, Kashmir, vide No. Div/Com/LAS-Const/3263/4071 dated 10-03-2018 and Financial Commissioner, Revenue vide No. FC-LS/LA-4631/2018 dated 03-04-2018 has been examined and it has been found that the land owners had filed objections and after examination which were disposed of in accordance with the rules

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz. for construction of road from Main road Berigam to Gundipota.

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring 01 Kanals and 05 Marlas & 07 Sirsai situated at village Berigam, Tehsil Devsar, District Kulgam, particulars whereof are given above, is required for public purposes viz. construction of road from Main road Berigam to Gundipot a. Further, the Collector Land Acquisition (ACR), Kulgam is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
