Whereas on the basis of an indent placed by Defence Estates Officer Jammu, a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Jammu South vide No. SDM/JMU-S/647-53 dated 21-07-2017 for land measuring 09 Kanal and 14 Marlas, situated in village Sunjwan, Tehsil Bahu, District Jammu;

Whereas the Collector Land Acquisition (SDM) Jammu South, vide No. SDM/J-S/LA/2017-18/1472-73 dated: 04-10-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act.**

Whereas the report furnished by Collector Land Acquisition (SDM) Jammu South vide number referred to above duly endorsed by Deputy Commissioner, Jammu vide No. DCJ/LA/Army/Sunjwan/2017-18/760-61 dated: 05-10-2017 and by Divisional Commissioner, Jammu vide No. 502/859/acq/Sunjwan/Jammu/2017/3327-30 dated: 08-11-2017 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given above is required **for public purpose viz. for Defence purpose, situated in village Sunjwan, Tehsil Bahu, District Jammu;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land **09 Kanal and 14 Marlas,** situated in village Sunjwan, Tehsil Bahu, District Jammu, particulars whereof are given above is required **for public purpose viz. for Defence purpose, situated in village Sunjwan, Tehsil Bahu, District Jammu.** Further, the Collector Land Acquisition (SDM) Jammu South, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.


