Whereas on the basis of an indent placed by Director Tourism, Jammu, vide No.DTJ/MJ/PS/1032-1035 dated:16-11-2011, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Reasi vide No. LA/ACR/Rsi/15/432-35 dated: 03-10-2015 for land measuring **64 Kanal and 02 Marlas**, situated in village **Poura Jagir**, Tehsil Pouni, District Reasi;

Whereas the District Collector (DC) Reasi vide No. DC/Rsi/17-18/719-25/SQ dated: 28-11-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by District Collector (DC) Reasi, vide number referred to above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for Construction of General Bus Stand in village Poura Jagir, Tehsil Pouni, District Reasi by Tourism Department; Now, therefore, in pursuance of Section 6 of the J&K

State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 64 Kanal and 02 Marlas, situated in village **Poura Jagir**, Tehsil Pouni, District Reasi, particulars whereof are given above is required for **public purpose viz. for Construction of General Bus Stand by Tourism Department**. Further, the Collector Land Acquisition (ACR) Reasi is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation. amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
