Whereas on the basis of an indent placed by the Senior Superintendent of Police, Kulgam vide No. GB/JKHPMC-324/2016/12533 dated: 05-07-2016, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Kulgam vide No. DCK/LA-564/2017/605-612 dated: 11-09-2017 for land measuring **41 Kanals and 16 Marlas**, situated in village Wubar Chowgam, Tehsil Devsar, District Kulgam

Whereas the District Collector (DC) Kulgam, vide No. DCK/LA-564/2017/741-45 dated: 02-12-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition and one person, namely, **Shri Abdul Rashid Parray S/O Ghulam Mohammad Parray R/o Chowgam** had filed objections under section 5(A) of the Land Acquisition Act and after examination of the said objections which were devoid of any merit, were rejected, as reported by the District Collector, Kulgam.

Whereas the report furnished by District Collector (DC) Kulgam vide number referred to above duly endorsed by Divisional Commissioner, Kashmir vide No. DivCom/LAS-Acq/3275/3619 dated: 21-12-2017 and by Financial Commissioner, Revenue vide No. FC-LS/LA-4590/2018 dated 16-01-2018 has been examined and it has been found that one person had filed

objections and after examination which were disposed off in accordance with the law;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz **for construction of alternate accommodation in village Wubar Chowgam,, Tehsil Devsar, District Kulgam by Police Department;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **41 Kanals and 16 Marlas**, situated in village Wubar Chowgam, Tehsil Devsar, District Kulgam, particulars whereof are given above is required for public purpose viz. **for construction of alternate accommodation in village Wubar Chowgam, Tehsil Devsar, District Kulgam by Police Department.** Further, the Collector Land Acquisition (ACR) Kulgam is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation, amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
