Whereas the land specifications whereof are given in "Annexure "A" to this notification is required for **public purpose viz. for establishment of BOP in village Maljodha, Tehsil Pargwal, District Jammu by Border Security Force;**

Whereas on the basis of an indent placed by Inspector General HQ Jammu FTR BSF vide No. Axxv/BOP/C-Maljodha/Engg/2013/ 1950-52, dated: 05-03-2013, a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Khour vide No. SDM/Rdr/K/2016-17/375 dated 24-06-2016 for land measuring 65 Kanals and 09 Marla, situated in village Maljodha, Tehsil Pargwal, District Jammu;

Whereas the Collector Land Acquisition (SDM) Khour vide No. SDM/Rdr/K/2016-17/438 dated: 25-10-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition, **but, no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (SDM) Khour vide No. referred above duly endorsed by Deputy Commissioner, Jammu vide No. DCJ/LA/BoP/2017-18/1349-50 dated: 28-12-2017 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given in "Annexure-A" to this notification, is required for **public purpose viz. for establishment of BOP in village Maljodha, Tehsil Pargwal, District Jammu by Border Security Force;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 65 Kanals and 09 Marla, situated in village Maljodha, Tehsil Pargwal, District Jammu,

particulars whereof are given in "Annexure -A" to this notification, is required for public purposes viz. for establishment of BOP by Border Security Force. Further, the Collector Land Acquisition (SDM) Khour is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
