v. No diversion of transferred land for any other purpose shall be made without the prior approval of competent authority.

vi. Litigation, if any to be contested by the indenting department.

vii. The indenting department to take possession of the land within 30 days from the transfer Order, and land to be put to use within 03 years failing which the land shall revert back to the Government.

viii. The Government reserves the right to retrieve any un-utilized portion of the land from the department, if the same is required for any other public purpose.
