**Subject: Transfer of land in favour of School Education Department for construction of Government Boys High School at Dahama, Tehsil Villagam, District Kupwara.**

Dated: 03.01.2024**

Sanction is hereby accorded to the transfer of Shamilat Deh (Mehfooz Kahcharie) land measuring 10 Kanal under survey No.31 min situated at village Dahama, Tehsil Villagam, District Kupwara in favour of School Education Department for construction of Government Boys High School.

It shall be subject to the following conditions:-

- i. The land shall be used only for the purpose for which the sanction of transfer has been accorded.
- ii. The land shall put to use after obtaining all other permissions as may be required for its construction from the Competent Authority.
- iii. The user department shall adhere to all such provisions of laws relating to Revenue/Forest/J&K Water Resources (Regulation and Management) Act, 2010/Housing & Urban Development Department etc.
- iv. It would be the responsibility of the user department to comply with directions of the Hon'ble High Court of J&K or any other competent Court with regard to the usage of the said land.
- v. No diversion of transferred land for any other purpose shall be made without the prior approval of competent authority.
- vi. Litigation, if any to be contested by the indenting department.
- vii. The indenting department to take possession of the land within 30 days from the transfer Order, and land to be put to use within 03 years failing which the land shall revert back to the Government.
- viii. The Government reserves the right to retrieve any un-utilized portion of the land from the department, if the same is required for any other public purpose.


