It shall be subject to the following conditions:-

- The land shall be used only for the development/public purpose i.e for which the sanction of transfer has been accorded.
- The land shall put to use after obtaining all other permissions as may be required for its construction from the Competent Authority and pay any charges/compensation of the said land if applicable.
- The permission shall be subject to the adherence of such other provisions of laws relating to Revenue/forest/J&K Water Resources (Regulation and Management) Act, 2010/Housing & Urban Development Department etc.
- It would be the responsibility of the user department to comply with directions of the Hon'ble High Court of J&K or any other competent Court with regard to the usage of the said land, and contest the litigation if any pending.
- No diversion of transferred land for any other purpose shall be made without the prior approval of competent authority.
- The Government reserves the right to retrieve any un-utilized portion of the land from the department if the same is required for any other public purpose.
