- b) The salary of the appointee shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) above is received in their favour.
- c) The appointee shall be initially on probation for a period of two years.
- d) The appointment of the candidate shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide SO 192 of 2020 dated 17.06.2020.
- e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
