## Government Order No: 120 -JK (Rev) of 2023 Dated: 25 .08.2023

Sanction is hereby accorded to the transfer of land measuring 37 Kanal 07 Sarsai at 93 different locations as per description at **Annexure-A** in favour of BSNL (Government of India Enterprise) for saturation of 4G mobile services in district Reasi, Udhampur, Doda, Shopian, Baramulla, Pulwama, Ramban, Kishtwar & Rajouri in terms of authorization pursuant to Administrative Council Decision No.26/3/2023 dated 25.04.2023.

- i. The land is transferred on as is where is basis and shall be used only for the purpose of saturation of 4G Mobile Services by BSNL after obtaining all other permissions as may be required for construction from the Competent Authority.
- ii. All the provisions of laws relating to Revenue/Forest/J&K Water Resources (Regulation and Management) Act, 2010/Housing & Urban Development Department, Jal Shakti Department etc shall be adhered by the user department and to comply with directions of the Hon'ble High Court of J&K or any other competent Court with regard to the usage of the said land, and contest the litigation if any pending.



iii. This order shall not debar any competent authority to take legal action in case of violation by the indenting department on the field relating to usage of land.
