Subject: Transfer of State Land measuring 32 Kanal in favour of BSF for establishment of Border Out Post (BOP) namely "Paharpur Fwd".

Dated: 14.09.2023**

Sanction is hereby accorded to the transfer of State land measuring 32 Kanal under Khasra No.454/174 min, 176, 178, 180, 460/177 min & 461/177 min situated in Village Mada, Tehsil Marheen, District Kathua in accordance with Rule 310 of General Financial Rules, 2017 in favour of Ministry of Home Affairs, Government of India for establishment of Border Out Post (BOP) namely "Paharpur Fwd" by Border Security Force (BSF) on payment of transfer value of Rs. 57,60,000 (Fifty Seven Lac Sixty thousand only) i.e 1,80,000/- per kanal.

It shall be subject to the following conditions:-

- i. The transfer value of the land shall be deposited in the official bank account of the Deputy Commissioner, Kathua, who shall further deposit in the account head of Government of J&K, Major Head 0029- Land Revenue, Minor Head 800 - Other Receipts.
- ii. The land shall be used only for the purpose for which the sanction of transfer has been accorded.
- iii. The land shall be put to use after obtaining all other permissions as may be required for its construction from the Competent Authority and pay any charges/compensation of the said land if applicable.
- iv. The land shall be on as is where is basis and nothing in this order shall be construed to debar any competent authority to take legal action in case of violation on the field relating to usage of land.
- v. The transfer shall be subject to the adherence of such other provisions of laws relating to Revenue/Forest/J&K Water Resources (Regulation and Management) Act, 2010/Housing & Urban Development Department etc.
- vi. It would be the responsibility of the user department to comply with directions of the Hon'ble High Court of J&K or any other competent Court with regard to the usage of the said land, and contest the litigation if any pending.

- vii. No diversion of transferred land for any other purpose shall be made without the prior approval of competent authority.
- viii. The Government reserves the right to retrieve any un-utilized portion of the land from the department if the same is required for any other public purpose.
