The appointee shall report to the Divisional Commissioner, Kashmir within a period of 21 days from the date of issue of this order and shall be allowed to join only on production of the following documents/certificates (in original), to be verified subsequently:-

- i. Academic/Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.

- iv. Domicile Certificate issued by the Competent Authority.
- v. If the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre(DIC) and District Employment and Counseling Centre of the domicile District, he /she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government services. He /she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his /her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- vi. Valid relevant Category Certificate, if any applicable.

The above appointment shall further be subject to the following conditions:-

- a. The appointee shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification/ category certificate from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- b. The salary of the appointee shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) above is received in their favour.
- c. The appointee shall be initially on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
- f. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances.
- g. The appointment(s) shall be cancelled ab-initio, if it is found that the candidate(s) is/are having higher qualification than the prescribed one at any stage later on, they shall also be liable for criminal prosecution.
- h. This appointment order is issued subject to outcome of any petition (s) pending in any competent Court/Tribunal, etc.
- i. If the appointee fail to join within a period of 21 (twenty one) days from the date of issuance of this order, they shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- j. The appointee shall give an undertaking that they have no criminal records and no criminal proceeding is going on against them in any Court of Law.

- k. The appointee shall have to execute an agreement with the Government on the form, forming annexure to the Jammu & Kashmir Migrants (Special Drive) Recruitment Rules, 2009 notified vide SRO-412 of 2009 dated 30.12.2009 read with SRO-425 of 2017 dated 10.10.2017.
