Sanction is hereby accorded to the advance drawal of Rs.71.00 lakhs (Rupees Seventy One Lakhs Only) under Major Head 4059- Capital outlay on Public Works Sub Head 1050- Director Land Records Detailed Head 115- Works in favour of Financial Commissioner (Revenue), J&K, Jammu for its further placement at the disposal of BSNL for purchasing of CUG-services from BSNL as single source selection to field functionaries as one time assistance out of Capex Budget.

The advance drawal shall, however, be subject to the following conditions:-

1. That the funds shall be utilized strictly as per originally Approved components .
2. Drawing and Disbursing Officer of respective office shall vouchsafe the availability of funds.
3. That the Administrative Department shall be updated with status report about the expenditure of the funds.
4. That the utilization certificates of the funds released shall be furnished to the Administrative Department, as early as possible so that the same is submitted to Finance Department.
5. That the Financial Advisor/CAO, Revenue Department shall be apprised about the utilization of Funds to enable him to vouchsafe the utilization, as per codal procedures/ Government of India's guidelines.
6. That the list of purchased CUG-services from BSNL shall be submitted to Administrative Department.


