Sanction is hereby accorded to the:

- i. transfer of land measuring 135 Kanal - 02 Marla (State/ Kahcharie) at Shariefabad, District Budgam in favour of Ministry of Defence, Government of India as part of EVL in lieu of Tatoo Ground land.
- ii. transfer of State land measuring 23 Kanal - 13 Marla under Khasra No 385 (18 kanal 10 Marla) and Khasra No. 507 (05 Kanal 03 Marla) in estate Rakh Buran, Tehsil Singhpora, District Baramulla in favor of Ministry of Defence, Government of India, as part of EVL in lieu of Tatoo Ground land.
- iii. In-Principal approval of the Govt. of J&K for taking up the matter with Ministry of Home Affairs (MHA), Government of India for transfer/taking over 150 Kanal - 15 Marla - 91 Sft at Rakhi Gund Aksha, District Srinagar from Ministry of Defence (GOI) against EVL to be identified by Divisional Commissioner, Kashmir.

 It is further ordered that the transfer of land shall be in terms of Rule 310 of General Financial Rules, 2017 on "no profit no loss basis" i.e. EVL basis as per the mutually agreed terms and conditions.


