Sanction is hereby accorded to the transfer of land measuring 3998 Kanal 08 Marla in District Samba (1954 Kanal 06 Marla) & District Pulwama (2044 Kanal 02 Marla) UT of J&K from Health and Medical Education Department in favour of Ministry of Health & Family Welfare (MoHFW), Government of India for construction of All India Institute of Medical Sciences (AIIMS), Jammu/ Kashmir, in terms of Rule 310 of General Financial Rules, 2017 without any cost as per of MoU between Government of India & Union territory of Jammu & Kashmir.

- i. The land shall be used only for the purpose for which the sanction of transfer has been accorded and no diversion of transferred land for any other purpose shall be made.
- ii. Health and Medical Education Department, Union territory of Jammu and Kashmir shall take further action in terms of MoU and if any, terms and conditions regarding the transfer of the said land with the Ministry of Health and Family Welfare, Government of India.
