- b. The salary of the appointees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) above is received in their favour.
- c. The appointees shall be initially on probation for a period of two years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e. The inter-se-seniority of the appointee shall be strictly as per their merit in the select list.
- f. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances.
- g. The appointment(s) shall be cancelled ab-initio, if it is found that the candidate(s) is/are having higher qualification than the prescribed one at any stage later on, they shall be also liable for criminal prosecution.
- h. This appointment order is issued subject to outcome of any petition (s) pending in any competent Court/Tribunal, etc.
- i. If the appointees fail to join within a period of 21 (twenty one) days from the date of issuance of this order they shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
