- v. It would be the responsibility of the user department to comply with directions of the Hon'ble High Court of J&K or any other competent Court with regard to the usage of the said land, and contest the litigation, if any pending.
- vi. No diversion of transferred land for any other purpose shall be made without the prior approval of competent authority.

vii. The Government reserves the right to retrieve any un-utilized portion of the land from the department if the same is required for any other public purpose.
