- Director Finance, Revenue shall be apprised of about utilization of funds to enable her to vouchsafe the utilization as per codal procedure.
- 4. That the funds so released shall not be available for reappropriation/diversion/deviation at any level.
- 5. That the funds shall be utilized strictly for the purpose for which it is meant.
- 6. That the funds shall not be parked in the bank account but utilized immediately after its drawl.
- That the UCs/Red account shall be submitted to the concerned quarters well within the stipulated time but before 31-03-2020 under intimation to this Administrative Department.

The expenditure shall be debited to the appropriate Account Head as already intimated vide Govt. Order No. 07-JK(Rev) of 2020 dated 17.01.2020.
