The appointees shall report to the concerned Deputy Commissioners within a period of 21 days from the date of issue of this order and shall be allowed to join only on production of the following documents/certificates (in original), to be verified subsequently:-

- Academic Qualification Certificates. i.
- ii. Date of Birth Certificate.
- Domicile Certificate. iii.
- Health Certificate from the concerned Chief Medical Officer of the District. iν.
- No loan certificate under Self Employment Scheme from DIC concerned and v. **Employment Department**
- Relevant category certificate. νi.

The above appointments shall further be subject to the following conditions:-

- a. The appointees shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification/ category certificate from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- b. The salary of the appointees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) above is received in their favour.
- c. The appointees shall be initially on probation for a period of two years.



- d. The appointment of the candidates shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide SO 192 of 2020 dated 17.06.2020.
- e. The appointment of the candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f. The inter-se-seniority of the appointees shall be strictly as per their merit in the select
- g. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances.
- h. The appointment(s) shall be cancelled ab-initio, if it is found that the candidate(s) is/are having higher qualification than the prescribed one at any stage later on, they shall also be liable for criminal prosecution.
- i. This appointment order is issued subject to outcome of any petition (s) pending in any competent Court/Tribunal, etc.
- j. If the appointees fail to join within a period of 21 (twenty one) days from the date of issuance of this order, they shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- k. The appointees shall give an undertaking that they have no criminal records and no criminal proceeding is going on against them in any Court of Law.
- The appointees shall have to execute an agreement with the Government on the form, forming annexure to the Jammu & Kashmir Migrants (Special Drive) Recruitment Rules, 2009 notified vide SRO-412 of 2009 dated 30.12.2009 read with SRO-425 of 2017 dated 10.10.2017.
