Sanction is hereby accorded to the grant of land on lease @ 8 Marla each to the 32 families of village Satwari, Tehsil Jammu South, District Jammu, and @ 06 Marla each to 29 families of village Narwal Pain, Tehsil Jammu South, District Jammu, affected due to Airport expansion (Annexure A1 & A2) for rehabilitation purpose, out of the piece of land identified by the Deputy Commissioner Jammu, measuring 32 Kanal situated in Khasra No.883 of village Sunjwan, Tehsil Bahu, District Jammu, under the J&K Land Grant Act 1960. The individual lease agreement shall be executed by the Deputy Commissioner, Jammu in favour of each beneficiary family as per the provisions of the J&K Land Grant Act and Rules there under and subject to the condition that land leased shall be used only for the purpose for which it is granted. The Deputy Commissioner, Jammu, shall be the Nodal Officer to ensure rehabilitation and resettlement of the affected families by way of allotment of plots in their favour and disbursement of financial assistance to 17 EWS families (Annexure B) and developing the basic infrastructure in the colony out of the funds agreed by the Finance Department.
