Sanction is hereby accorded to the:

- i. Transfer of State land measuring 757 Kanal 06 Marla as per description in **Annexure-A** situated at village Rakh Buran, Tehsil Singhpora, District Baramulla in favour of Ministry of Defence, Government of India in exchange of Equal Value Land (EVL) at Tattoo Ground Srinagar on no profit no loss basis in terms of Rule-310 of GFR 2017. The land shall be the part of the EVL of the land for which sanction was conveyed by MoD vide No.A/51120/Q3L (North)/181/31/S/ D(Lands) dated 22<sup>nd</sup> February 1990 and the Divisional Commissioner, Kashmir in consultation with defence authorities shall work out the actual value of the land on EVL basis at all locations.
- ii. "In principle" approval of the Govt. of J&K for transfer of 139.04 acres of defence land at Tattoo Ground Srinagar in favour of Ministry of Home Affairs, Government of India on EVL basis for the purpose of promotion of tourism and other developmental activities by the UT of J&K and further signing of the MoU between the parties.




