In continuation to this department's Government Order No. 73-JK(Rev) of 2021 dated 21.10.2021, sanction is hereby accorded to the temporary appointment of Shri Saquib Ahmad Parry, S/O Jaweed Ahmad Parry, R/O 88 Pahloo Peerpora Pahloo Kulgam as Class-IV in the Pay Level SL-1 (14800-47100) under RBA Category in the Revenue Department, District cadre Kulgam.

The appointee shall report to the Deputy Commissioner, Kulgam within a period of 21 days from the date of issue of this order and shall be allowed to join only on production of the following documents/certificates (in original), to be verified subsequently:-

- i. Academic Qualification Certificates.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department
- vi. Relevant category certificate.

The above appointment shall further be subject to the following conditions:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification/ category certificate from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c) The appointee shall be initially on probation for a period of two years.
- d) The appointment of the candidate shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide SO 192 of 2020 dated 17.06.2020.
- e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.

- f) The inter-se-seniority of the appointees shall be strictly as per his merit in the select list.
- g) The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances.
- h) The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he shall be also liable for criminal prosecution.
- i) This appointment order is issued subject to outcome of any petition (s) pending in any competent Court/Tribunal, etc.
- j) If the appointee fail to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- k) The appointee shall give: an undertaking that he has no criminal records and no any criminal proceedings is going on against him in any Court of Law.
