- v. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department
- vi. Relevant category certificate.

The above appointments shall further be subject to the following conditions:-

a) The appointees shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification/ category certificate from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.

b) The salary of the appointees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) above is received in their favour.
