- a) The appointees shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification/ category certificate from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- b) The salary of the appointees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) above is received in their favour.
- c) The appointees shall be initially on probation for a period of two years. d) The appointment of the candidates shall be governed in terms of Jammu and
- Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide SO 192 of 2020 dated 17.06.2020.

- e) The appointment of the candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
