As recommended by the Empowered Committee and in terms of the J&K Civil Services (Special Provisions) Act, 2010, sanction is hereby accorded to the regularization of services of Shri Des Raj S/o Shri Kunj Lal R/o VPO Rasoo, Kathua (Contractual Jr. Assistant), as Junior Assistant in the pay scale of Rs. 5200+20200 + GP 1900 in the Revenue (Subordinate) Service, District Cadre, Kathua, prospectively, in relaxation of upper age bar by 09 months and 26 days as on 01.01.2018.

The regularization further shall be subject to the following terms and conditions:-

- The said appointee has not been selected by any recruiting agency/or appointed in any other Government Department.
- II. The allowances other than what were admissible/due have not been drawn and the excess allowances, such as HRA/CCA and MA, if any drawn/paid to him shall be recovered.
- III. The incumbent is working against clear vacancy post.
- IV. The said incumbent shall report to the Deputy Commissioner
   Kathua who shall allow him to join subject to the production of
   following certificates/documents in original:
  - a. Academic/Technical Qualification Certificates.
  - b. Date of Birth Certificate.
  - c. Health Certificate issued by the Competent Authority.
  - d. Permanent Resident Certificate.

- Relevant Category Certificate (in case the candidate belongs to reserved category).
- f. Certificate from General Manager, DIC concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.
- V. The incumbent shall initially be on probation for a period of two years.
- VI. The salary of the incumbent shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner concerned.
