In terms of clause (2) of Article 256 of the Constitution of India, as applicable to the State, sanction is hereby accorded to the transfer of State land measuring 100 Kanals and 14 Marlas, under Khasra No. 1115/585, situated in village Jodhpur, Tehsil and District Doda, to the Kendriya Vidyalaya Sangathan through Union of India, on lease basis, for a period of 40 years in the first instance, free of premium and on payment of ground rent @ Re 1/- per Kanal per annum for establishing a Kendriya Vidyalaya at Doda, subject to the following terms and conditions:-

- i. The lessee shall not use the land for the purpose other than establishing a Kendriya Vidyalaya (Central School).
- ii. The lessee shall not sublet, assign or otherwise part with the possession of the land or any part thereof including buildings without obtaining prior permission of the State Government; and

iii. In the event of closure of the Institution or of the Scheme in the State of Jammu and Kashmir, the lessee shall handover the possession of the land including the buildings to the State Government without claiming any compensation.
