During on-the-job training, it shall be ensured that:-

i) the probationers remain in touch with the Lambardars/Chowkidars for at least 03 days.

- they shall be associated with the Patwaries and office of the Girdawar/Qanoongo to understand the compiling and mechanism involved in formulation of Girdawari, Jamabandi, Parat-Patwar, Parat-Sarkar, Misl-e-Haqiyat (RoRs), Lal Kitab, Roznama, Waqiati etc; and
- they shall be allowed to attend the Court when the Tehsildar or Naib Tehsildaract exercises his powers as Executive Magistrate  $1^{\rm st}$  Class/Assistant Collector  $1^{\rm st}/2^{\rm nd}$  Class.

The concerned Tehsildar with whom the probationers are attached shall furnish a report of the conduct of the probationer at the end of the period of probation, for its further transmission to the General Administration Department.
