Subject:- Delegation of powers regarding transfer of State/ Departmental land to the Government Departments/ agencies for various public purposes.

Reference:- State Administrative Council Decision No. 44/5/2019 dated 13-02-2019.

Government Order No:-3° -Rev (S) of 2019 Dated:-05 -03-2019

In partial modification of Cabinet Decision No. 136/11/2009 dated 01.10.2009, it is hereby ordered that the proposals regarding transfer of State/Departmental land for various public purposes shall be processed for consideration/orders of the authorities as under:-

- a) Government in the Revenue Department shall be competent to decide cases relating to transfer of state/departmental land exceeding 100 Kanals and upto 500 Kanals (free from encumbrances) to the state government department (s) for public purposes/developmental programmes.
- b) The Divisional Commissioner concerned shall be authorised to decide the cases relating to transfer of state/departmental land exceeding 10 Kanals and upto 100 Kanals (free from encumbrances) to the state government department (s) for public purposes/developmental programmes, within his territorial jurisdiction.
- c) The Deputy Commissioner concerned shall be authorized to decide the cases relating to transfer of state land upto 10 Kanals (free from encumbrances) to the state government department (s) for public purposes/developmental programmes, within his territorial jurisdiction.

It is further ordered that:-

i. the transfer of land in terms of delegation as at (a), (b) and (c) above shall be subject to the condition that prior approval to the execution of

the project is obtained by the indenting Department from its competent authority and conveyed to the appropriate revenue authorities in the first instance; and

ii. in circumstances where the concerned Department (under whose possession the land is recorded) does not convey no objection/consent to part with land due to any reason, the case (s) shall be submitted to the State Administrative Council/State Cabinet for consideration.
