Final seniority list of Revenue Gazetted Service (Tehsildars) as it stood on 01.04.2019

Government Order No.61 -Rev(Gaz) of 2019 Dated: 23 -04-2019

Whereas, the final seniority list of Revenue Gazetted Services as it stood on 15.03.2016 was notified vide Government Order No. 42-Rev (Gaz) of 2016 dated 29.03.2016, under endorsement No.Rev/Gaz/2011 dated 29.03.2016;

Whereas, 12 officers (Tehsildars) figuring in the said seniority list have been inducted into the Time Scale of J&K Administrative Services, vide Government order No.457-GAD of 2016 dated 27.04.2016 read with Government Order No.1641-GAD of 2017 dated 22.12.2017, issued by the General Administration Department and some have retired on attaining the age of superannuation;

Whereas, it was necessary to revise the seniority list of Revenue Gazetted Services to set right the records and accordingly vide Government Order 154-Rev(Gaz) of 2018 dated 28.08.2018, a tentative seniority list of Revenue Gazetted Service (Tehsildars) as on 01.07.2018 was circulated among the concerned Tehsildars for inviting objections from the concerned who feels aggrieved and may not be satisfied with the position assigned to him in the tentative seniority list, may submit his/her representation with documents/proof in support of his/her objections within a period of 21 days;

Whereas, in response to the said tentative seniority list 02 Tehsildars namely Ms. Nushrat and Muzaffar Ahmad Malik have filed their objections against the said tentative seniority list;

Whereas, Ms. Nusrat, Tehsildar has filed objection against the tentative seniority list regarding arranging her position as per the seniority list of Naib Tehsildars issued by the Financial Commissioner (Revenue). The objections filed by her have been examined and the matter was also taken up with the, J&K Public Service Commission for consideration for giving the

retrospective effect in promotion. In turn the J&K Public Service Commission vide communication No.PSC/DPC/Rev/11/2013 dated 15.01.2019 has informed that if the claim of the officer is genuine and the incumbent is similarly situated as that of her counter parts/junior who were given the similar benefits/treatment in the past/ the department may, if deem fit and wants to extend the similar treatment as part of natural justice, may take a decision of relaxation of rules/exemption or otherwise, as required , on the analogy of other similarly situated candidates, based on the advice of Law Department. After obtaining approval of the competent authority, the proposal with full details can be placed before the DPC/PSC for consideration. The J&K PSC has no role to play in the matter at this stage. As such, her case has not been found on merits as her seniority has already been fixed at the appropriate place as per the substantive appointment/promotion as Tehsildar as envisaged under J&K Civil, Services (Classification, Control and Appeal) Rules, 1956; and

Whereas, on examining the objections filed by Mr. Muzaffar Ahmad Malik Tehsildar, it has been found that the officer was appointed as Naib Tehsildar with effect from 21.05.1999 vide Government Order No.Rev (NG)105 of 2002 dated 29.05.2002. After attaining his eligibility/qualifying the departmental examination on 01.12.2011, he was confirmed/regularised on the basis of recommendations made by J&K PSC/DPC as Tehsildar notionally w.e.f.01.12.2011 vide Government order No.Rev(Gaz)293 of 2014 dated 22.12.2014 and the case has been found genuine for fixing his position in the seniority list of Tehsildars at appropriate place;

Whereas, after examining the objections filed by these Officers, some insertions/corrections have been incorporated in the tentative seniority list of Tehsildars at appropriate places and vide circular No.08-Rev (Gaz) of 2019 dated 28.02.2019, a revised tentative seniority list of Tehsildars (excluding the retired Tehsildars) as it stood on 01.02.2019, was circulated again among the concerned Tehsildars for inviting objections from the concerned who feels aggrieved and may not be satisfied with the position assigned to him in the tentative seniority list, may submit his/her representation with documents/proof in support of his/her objections within a period of 21 days failing which it shall be presumed that the concerned officer(s) has/have no objection in the matter and the final seniority list shall be notified accordingly;

Whereas, against the aforesaid revised tentative seniority list of Tehsildars, no objections has been received by the Administrative Department.

Now, therefore, a revised/updated seniority list of the officers/members of Revenue Gazetted Service (Tehsildars) as it stood on 01.04.2019 forming annexure to this order is hereby circulated among all the officers/members of the service for their information.

Any Officer still aggrieved with the position assigned to him/her may file an appeal as provided under the Jammu and Kashmir classification control and appeal rules, 1956 within a period of one month from the date of issuance of this order.

The date of birth recorded in the seniority list shall be subject to further verification from the Service Books/matriculation certificate of the concerned Officer.
