Sanction is hereby accorded to the transfer of State land measuring 40 Kanals and 01 Sirsai, under Khasra Nos. 285, 286, 287, 288, 289, 291 to 293, 296 to 299, 300 to 302, 323 to 327 min (under occupation of Sericulture Department), and 284 min (under the occupation of PHE Department), situated in village Sarnal, Tehsil and District Anantnag, to the Department of Law, Justice and Parliamentary Affairs, for establishing/relocation of District Court Complex Anantnag.

It is further ordered that:-

- Deputy Commissioner, Anantnag, shall identify suitable alternate land for utility shifting of PHE Department, if required/existing on the land, being utilized for construction of the District Court Complex.
- ii. The Department of Law, Justice and Parliamentary Affairs, shall augment appropriately the PHE and Sericulture Departments in terms of providing requisite funds for purposes of utility shifting (PHE) and relocation of Mulberry Culture (Sericulture) of the said Departments, at the respective new locations.

Necessary orders regarding transfer of alternate land to the Sericulture Department for relocating Mulberry Culture shall be issued separately.
